#### **Comments by the President**

President Ted Schriver shared that he recently met with Andrew Lipian to update him on the Library's progress in planning for future expansion. He also noted the Library's presence at future community events, including a Midview School Rally and the Lorain County Fair.

#### **Public Comments**

Andrew Lipian spoke on the Village's support for keeping the Library in the Village and their openness to partner with the Library in the future.

#### **Meeting Minutes**

Evelyn Hemmingsen moved, and Mindy Harris seconded to accept Resolution #24-8-1, approving the minutes from the Board of Trustees Regular Meeting on July 9, 2024. All voted aye. Motion carried. Joe Urig abstained.

#### Fiscal Officer's Report

Lorie Scheer presented and reviewed the following financial reports at the meeting: Bank Report, Revenue Report, Expense Report, and Check Register for July 2024. Discussion followed.

Lorie reported minor adjustments to the Public Library Fund. Discussion followed.

President Ted Schriver stated that the July 2024 financial reports were received, reviewed, and ready to file for audit.

**Director's Report** 

Adele Infante shared additional reports: Web & Social Media for July 2024 and Adult Summer Reading Program Summary for 2024.

Adele asked which board members could attend the October 3rd Lorain County Library Trustees Meeting. Mindy Harris, Evelyn Hemmingsen, and Ted Schriver agreed to participate.

Adele detailed the Library's 80<sup>th</sup> Anniversary celebration on September 21 and asked the Board for bakery donations.

Adele announced staff departures following the resignations of Administrative Assistant Tawnja Hammond and temporary Youth Services Associate Kelly De Gross to return to teaching. Adele also announced that Library Page Brock Greene expressed interest in a Youth Services position and will begin training for the Associate position.

Pam Myers provided information about the Youth Services department and detailed the source of program ideas, the types of programs offered, the planning documents used, recent programs offered, and future programs planned. A discussion followed.

**Committee Reports** 

Building Committee: Simplified Facilities scheduled a bollard replacement on the parking lot side of the building.

Finance Committee: no updates.

Personnel Committee: no updates.

Planning Committee: Ted provided updates on the Demby property as a potential site for future library expansion. There were no updates for the school site. Discussion followed.

Adele asked for a deadline to add a bond issue or a tax levy to an upcoming ballot. Discussion followed.

The Board agreed to further discussions with Studio GC to determine the financial amounts to set for a bond issue/tax levy potentially in May 2025.

Social Committee: The Committee will discuss options for an upcoming staff event at the next meeting.
