### **Director's Report**

Adele addressed the need to make the Library's website ADA-compliant in accordance with Department of Justice requirements. These changes must be implemented by March 2027. Discussion followed.

Adele informed the board that the certified election results from November are now available. She also reported on her attendance at the most recent LCLAC meeting. Library directors considered offering a meeting for library board members throughout Lorain County to discuss current issues. Discussion followed.

### **Midview Board of Education**

Clare Gallaher reported on the November meeting. The meeting included details of a local business initiative led by Oscar's Barn (Annika's Event Center and Bella Creamery) to pay off student lunch balances.

Athletic Director Dan May reported (at the meeting) that student athletes in fall sports achieved an average GPA of 3.6. In addition, the Cleveland Browns are funding a girls' flag football program at Midview.

### **Old Business**

The board reviewed the purchase agreement with the Village of Grafton for the acquisition of the green space adjacent to the Library. Discussion followed.

Clare Gallaher moved, and Mindy Harris seconded to accept Resolution #25-12-5, approving the purchase agreement for the green space next to the Library from the Village of Grafton. All voted aye. Motion carried.

Adele selected a closing date of 12/12 for the Eaton Twp. Branch. Simplified is moving items back to the Library and 963 Main Street.

### **New Business**

Adele reviewed door count statistics at the Library. She intends to close the Library on Sundays and close at 5 pm on Fridays beginning in January. Discussion followed.


### **Good of the Cause**
