## Director's Report

Adele Infante noted Old Fashioned Christmas was a success, with 500 people attending within the library and almost 200 books passed out to children who visited with Santa. With the new children's librarian, the winter offerings now include Storytime again. The Board discussed a list of discarded technical equipment included in their packet. The list consists of outdated equipment and devices no longer needed. Some items were sold to the public at a discount, and the rest were donated to recycling. Ted Schriver moved, and John Dixon seconded to accept Resolution #22-12-4, approving the GMPL Equipment Removed 2022 list. All voted aye. Motion carried.

#### Personnel Committee

Given the challenges the library staff faced this year with vacancies and illness, Adele requested an increased amount for holiday bonuses as many employees readily covered positions in other departments. Discussion followed. Angela Carter moved, and Corey Heredos seconded to accept Resolution #22-12-5, approving a holiday bonus for all active employees with \$250 for full-time staff, \$125 for 20 + hours staff, and \$75 for 8 + hours staff.
